### FLINT RIVER PRESBYTERY 142nd Stated Meeting February 3, 2024

Jesus told them, "For truly I tell you, if you have faith the size of a mustard seed, you will say to this mountain, 'Move from here to there,' and it will move, and nothing will be impossible with you." (Matthew 17:20)

Flint River Presbytery met at New Hope Presbyterian Church (Columbus) for its 142<sup>nd</sup> Stated Meeting on Saturday, February 3, 2024, at 10:00 am. This meeting was co-hosted by Beth Salem Presbyterian Church (Columbus). Registration began at 9:00 am, and the Stated Clerk conducted an orientation for new commissioners at 9:30 am.

### GATHERING AS GOD'S PEOPLE

Pam Moye of New Hope and Patti Kauffmann of Beth Salem welcomed the presbytery to the meeting, gave comfort instructions, and presented a skit to acknowledge the transfer of the gavel today to a new moderator and to celebrate former moderators in attendance (Pam and Patti being two of them). They gave current moderator Joshua Bower a t-shirt and welcomed him to FORMA – Former Old Retired Moderators Association. He accepted membership in this elite group and the t-shirt with delight! All former moderators in attendance were asked to stand, and the presbytery applauded their service.

Moderator Joshua Bower called the meeting to order at 10:07 am and opened with prayer. A quorum was declared present (six minister members and six ruling elder commissioners, representing at least six congregations). He called on Sharita Hendley, Moderator of the Advisory Board, for the presentation of the agenda for approval. Moderator Bower asked for any corrections or additions, and hearing none, the agenda was approved.

The Moderator then called on Stated Clerk Becky Willis for roll call and introductions. She welcomed the commissioners, including several commissioners serving for the first time, and reminded everyone to register so all attendance will be recorded. The presbytery was thrilled to have Tom and Doris Granum, both children of Flint River Presbytery who have moved to Athens, Georgia, to serve as worship leaders today in song and musical accompaniment.

Moderator Bower, who served our presbytery faithfully during 2023, called upon the 2024 Moderator Curtis White, pastor of St. Andrews Presbyterian Church, to come forward for installation and blessing. The following questions were asked of our new Moderator: (1) As moderator of Flint River Presbytery, do you promise to lead us to listen – not to the loudest voices telling us what we want to hear – but to listen for the voice of Jesus and his will for us? (2) Do you promise to lead us in a way that all voices are heard, encouraging us to unity in Christ, not simply uniformity in thought? (3) Do you promise to moderate our presbytery with energy, intelligence, imagination, wisdom, and humor, clothing yourself, and us, in Christ's love? Upon hearing affirmative responses to each question, Moderator Bower offered a prayer of blessing,

declared Curtis White as the 2024 Moderator of Flint River Presbytery, gave him the moderator's cross and turned the leadership of the meeting over to him.

Doris Granum led the presbytery in singing "Come Thou Fount of Every Blessing" as the offering for the day was gathered. The offering for today will help support the vibrant campus ministries in Columbus and Americus with the "Noisy Offering" going to the FRP Hunger Fund. The offering at the August presbytery meeting will help support the campus ministries of Valdosta and Macon.

### **ENCOURAGING AND EQUIPPING GOD'S PEOPLE**

### Brief Reflection by Commissioned Pastor (CRE) Gary Cullison of First (Cordele)

Gary gave a beautiful and thought-provoking word based on Jesus' parable of the mustard seed as recorded in Matthew's Gospel. He reminded us that what seems insignificant in the world is often most significant in the Kingdom of God. As Scripture tells us, even faith as small as the tiny mustard seed can grow into something so large it can be a resting place for the birds of the air or strong enough to cause a mountain to move into the sea. He asked us to consider our own faith and how something we deem as small as a mustard seed can become great.

### Doris Granum led the presbytery in singing "Raise a Song of Gladness."

### **Information about our Joint Ministries**

Following worship, the Moderator referred the presbytery to pages 12-18 of the packet. In this section are reports from the Advisory Board, the Stated Clerk, and Committees and Commissions, representing many hours of dedicated work by members of the presbytery. The Stated Clerk reminded commissioners to review the annual membership roll found on pages 10-12 in the Attachments. She noted that First (Columbus) has one commissioner instead of two (per their Clerk of Session), so the total number of elder commissioners is 38 instead of 39, as shown on the membership roll.

The Moderator called on Karen Jones, representing the Committee on Evangelism and Nurture. Karen is the Clerk of Session at Northminster and has agreed to serve as the Montreat Coordinator. Her e-mail is <a href="montreat@flintriverpresbytery.org">montreat@flintriverpresbytery.org</a> and all should feel free to reach out to her with questions. Our youth will be going to Montreat June 8-15, and Karen invited all congregations to send as many youth as possible. The registration fee is around \$200, but there are other costs such as food and lodging, making the total fee \$550.00. The handling of fees is under discussion and will be communicated as soon as decided.

The Moderator then called on Ralph Hawkins, representing the Committee on Ministry. Ralph is the pastor of Northminster and the dean of the TRE classes. He acknowledged how valuable this program is in our presbytery and asked that all congregations consider ruling elders who might be trained to serve in pastoral roles, including chaplaincy, as well as pulpit supply, session moderators, community action leaders and other creative roles. The new cohort will begin classes on April 17. Ralph also talked about the new training videos entitled "We Are Flint River," which are adjunct training sessions for current elder training.

These 10-15 minute videos are useful for sessions and congregations, and four are currently available on our website. Additional videos should be available by our next presbytery meeting. Danny Dieth, on behalf of Louise Hurless, Director of Columbus Habitat for Humanity, brought news of ongoing activity and encouraged volunteers. Later, Louise arrived at the meeting and gave more specific information. Page 16 of the presbytery packet gives more information about this project. She noted that Publix has donated \$50,000 toward this project, which may take up to a year to finish depending on volunteer participation. She said a church across the street from the houses assists as needed. The recipient families of Habitat for Humanity houses put in "sweat equity" on their homes.

### Doris Granum led the presbytery in the hymn "The Lord Is My Light."

#### **Action Items**

The Moderator referred the presbytery to pages 19-20 for items needing action.

- Sharita Hendley, Moderator, presented the Advisory Board's recommendation that the Wisdom Overture from Forsyth Presbyterian Church, with concurrences from Northminster and Westminster, be approved by the presbytery and then submitted to the General Assembly for consideration and vote. The rationale for the overture is found on pages 19-20. The overture would change the wording in the Book of Order, Section W-4.0404h, to read: "Will you pray for and seek to serve the people with wisdom, energy, intelligence, imagination, and love?" Coming from a board/committee, no second was required. The motion carried. The overture will be communicated to the Office of the General Assembly.
- Properations The Advisory Board moves that "When the Synod of the South Atlantic meets, it shall consist of the thirty-eight (38) commissioners, thirty-two (32) elected from its constituent presbyteries and six (6) elected by the synod. Each presbytery shall elect two commissioners to staggered classes (one even year, one odd year): One Minister of the Word and Sacrament and one Ruling Elder, giving consideration of the issue of representation and inclusiveness as required by the Book of Order. The other six (6) commissioners shall be "At-Large" Commissioners. Of the six (6), three (3) shall be ruling elders, and three (3) Ministers of the Word and Sacrament, all of whom come from different presbyteries and at least one from each state (South Carolina, Georgia, and Florida).

Rationale: Currently, commissioners are only elected by the presbyteries, which means the synod has limited ways of fulfilling our own mission priority to "ensure full integration of diversity in all of its life and work." Recent changes to G-3.04 of the *Book of Order* allow

for the enrollment of additional commissioners for the purpose of representation. The hope is to include more of those involved in synod-wide racial ethnic ministries and build a more inclusive body.

This motion coming from a board/committee requires no second. The Moderator asked for discussion. A motion to amend the motion was presented by Tom McFarland, but this motion was ruled out of order by the Moderator on the advice of the Stated Clerk because it would change the wording of the *Book of Order*. The motion to amend was withdrawn. The main motion carried with one abstention.

### **Addendum Action Items**

The Moderator referred the presbytery to the Addendum Page. Frazer Loomis, Moderator of the Finance Committee, moved that the amended budget for 2024 be approved. This budget reflects small tweaks to acknowledge the actual amount pledged by congregations as well as to mirror expenses more closely in 2023 and can be found on the pages following this motion. It was noted that the dismissal of First (Donalsonville) last year and the decision by First (Bainbridge) not to pay their pledge this year have negatively impacted the budget. Coming from a committee, the motion needed no second. The motion carried. Executive Presbyter Debra Tregaskis asked each pastor within the presbytery to give at least \$10.00 per month to help offset the deficit. She stated she would "tithe" the amount given. For instance, if pastors gave \$10,000, she would give \$1,000; \$15,000, she would give \$1,500 and so on. Signs with the acronym IGiTDam (I Give \$10.00 a month) were scattered around the sanctuary.

In a dramatic highlighting of the history of the song "Wade In The Water," often sung by slaves as they worked, the presbytery sang this song as Linda Gunn of Beth Salem walked toward the baptismal font modeling the walk of Harriet Tubman, an historical icon in African American history, and a beacon of light in the journey toward freedom for the many people who suffered the injustices of slavery.

#### What Else? Embracing our Future with Awe

Executive Presbyter Debra Tregaskis spoke to the uncertainty of the future as she told the presbytery about the Presbytery of Tampa Bay, who now have scientific evidence that in approximately 75 years half their presbytery will be under water. Their Executive Presbyter has now been dubbed The Chief Imagination Officer! This begs the question, why focus on budgets and buildings when the very ground under us may not exist? She called us to I Samuel 17:38-50, the story of David and Goliath, which is the Scripture for the year 2024. As young David volunteered to go out and meet the giant Philistine Goliath, King Saul placed his own armor on David. The armor was far too big and too heavy, and David took it off. He met Goliath with no earthly armor and five smooth stones from the brook, and we know the end of that story! She posited three things to ponder: (1) When we shed all that weighs us down, we can fell giants. It is an act of release. (2) When we kneel at the water of our baptism, we shed our fears and turn outward; it is an act of remembering that we belong to God. (3) When David puts the stones in

his bag and hurls them at Goliath, he acts with boldness and topples the giant; it is an act of resistance. The five smooth stones are metaphors for resistance against fears and enemies, largely within.

God has stacked the deck in our favor, and we need not fear. She said, "This is our Kingdom cry: Lift up our hearts and hold out our hands." She challenged us to build a bridge not a battlefield and dubbed us all Chief Imagination Officers!

### ENGAGING AND EXPERIMENTING AS GOD'S PEOPLE

In the absence of Campus Minister Pablo Rivera of The Abbey, Danny Dieth shared information about the campus ministry at Columbus State University. Weekly Tuesday lunches are welcomed by the students and provided by local churches. Ministry is happening around the tables as bread is broken and relationships strengthened. There are several satellite campuses of Columbus State University, one of which is the School of Music. Many of the students studying there are from other countries and have very little money. Bags of food are provided by The Abbey for students to take with them in addition to the Tuesday lunches.

Sharon McFarland, long-time Treasurer and Board Member at The PresHouse in Americus, spoke about the changes that have occurred with the former campus minister moving and the hiring of Katie Minich as the new campus minister. There is a consistent group of students who come to the center for Monday and Thursday lunches and fellowship, and the board and Katie try to make the lunches special with holiday-inspired meals (Mardi Gras, St. Patrick's Day, etc.). Congregations were encouraged to help with the ministry and to reach out to Katie.

### Doris Granum led the presbytery in "Go To the World."

### God's Congregations: Our Stories (insights from our Small Church Coordinators)

Laura Peiper and Britanny DiGiammarino brought stories of what is happening in our small churches around the presbytery (Laura on the west side of Hwy 19 and Britanny on the east). From the food pantry at Beth Salem to the floor restoration at 2<sup>nd</sup> Thomasville, people are busy helping others. One of the main objectives of the Small Church Coordinators is to build connections with congregations and with communities. Getting out into the local communities and developing relationships is crucial. Helping people within the congregation and within the community deepen their relationship with God is the goal of all programs, activities, and outreach. The Creativity Fund was referenced as a great resource for creative ideas to make connections within and without the congregation. The presbytery was asked to participate in CEN's online survey to help make plans for mission and outreach efforts. A forum is being developed on the presbytery website for those who have watched "The Chosen." Also on the website is a children's sermon for Kirking O' the Tartans service.

### **Closing Worship: Remembering Our Baptism**

The Moderator referred the presbytery to page 21 of the packet for the order of service for the closing worship. The hymn "Lord You Give the Great Commission" began the service followed by a Litany of Remembrance. The hymn "I've Got Peace Like a River" preceded a brief reflection on baptism by Ralph Hawkins.

The presbytery was invited to come forward to "Kneel at the Brook" (I Samuel 17) and take a stone from the baptismal bowls generously loaned to us by Tom and Doris Granum. As people came forward to dip into the water and remember our baptism, the hymn "Come and Fill Our Heart" was sung.

Following the closing worship the presbytery was called into the Annual Meeting of the Corporation.

### ANNUAL MEETING OF FLINT RIVER PRESBYTERY, INC.

Moderator Curtis White called the meeting of the corporation to order and opened with prayer. The purpose of this meeting is to comply with the laws of the State of Georgia regarding 501 (c) 3 corporations and non-profit organizations, which require an annual meeting, and to elect officers. Officers elected by the Advisory Board, who serve as Trustees of the corporation, are: Sharita Hendley, President; Joshua Bower, Vice-President; Bryan Wright, Secretary; and Bill Krenson, Treasurer. The Moderator asked for discussion, objections, or nominations from the floor. Hearing none, these officers were elected by unanimous consent. Financial statements for the corporation are contained in the presbytery packet for today's meeting. Upon conclusion of business, the stated meeting of the presbytery and of the corporation were adjourned with prayer by the Moderator.

## FLINT RIVER PRESBYTERY Called Meeting of the Presbytery via Zoom March 12, 2024

Flint River Presbytery met via Zoom on Tuesday, March 12, 2024, for a called presbytery meeting. The purpose of the meeting was vote on the request of Barnesville Presbyterian Church to transfer from the Presbytery of Greater Atlanta to Flint River Presbytery.

Moderator Curtis White called the meeting to order at 2:00 pm, welcomed commissioners and all attendees, and opened the meeting with prayer. A quorum of at least six minister members and six ruling elders, representing at least six congregations, was declared present by the Stated Clerk. Moderator White inquired whether any Barnesville members were present and invited them to speak. No Barnesville members were present.

The Moderator read the Action Item, which had been sent out to the presbytery prior to the meeting giving adequate notice of the called meeting and reminders on "Tuesday's Treasures," and referred the presbytery to the included rationale for the proposed action. He then called for a motion regarding the Action Item. Jimmy Moye of 1<sup>st</sup> Columbus moved that the following action be taken: Pending action by the 226<sup>th</sup> General Assembly, Flint River Presbytery agrees to receive Barnesville Presbyterian Church of Lamar County into Flint River Presbytery from the bounds of the Presbytery of Greater Atlanta. It further requests that the Synod of the South Atlantic overture the General Assembly to transfer Lamar County, Georgia from the bounds of the Presbytery of Greater Atlanta to Flint River Presbytery.

Upon second by Glenn Gilstrap, the Moderator called for a voice vote. The motion carried unanimously.

Ralph Hawkins, pastor of Northminster, expressed his delight that Barnesville wishes to become part of Flint River. He said that the cluster hopes to have a welcome fellowship during the summer.

Stated Clerk Becky Willis reminded the presbytery that the reception of Barnesville will not be official until the synod overture is approved by the General Assembly.

The purpose of the called meeting complete, Moderator White declared the meeting adjourned and closed in prayer.

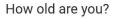

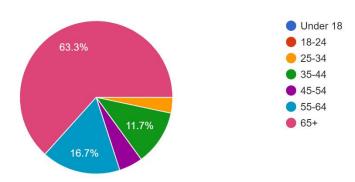

## FRP and Me Survey Results 61 Total Participants

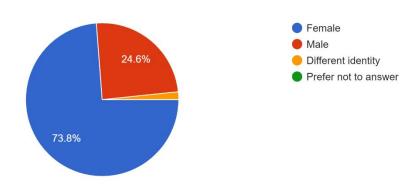

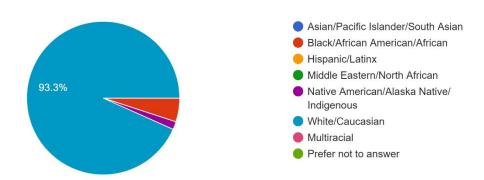
### What is your gender?

### What is your race or ethnicity?

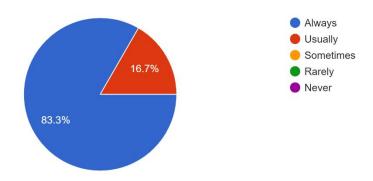

## FRP and Me Survey Results 61 Total Participants

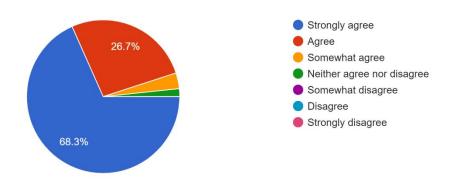
Flint River Presbytery responds to my questions.

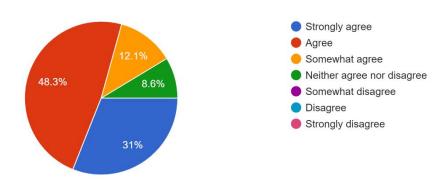
Flint River Presbytery supports my church.

I feel comfortable navigating Flint River Presbytery's website.

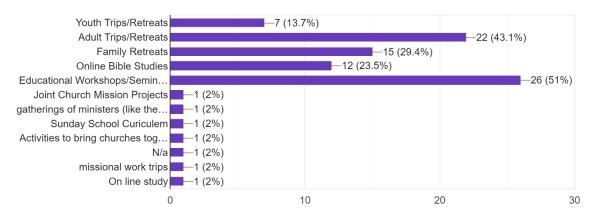

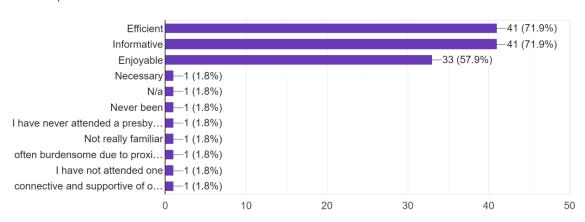
### I would like to see more \_ from FRP (check all that apply)
